UPUTE ZA PISANJE I PRIJAVU SAŽETAKA /

INSTRUCTIONS FOR WRITING AND SUBMISSION OF ABSTRACTS

Sažetak mora biti napisan na engleskom jeziku. Sažeci neće biti lektorirani te odgovornost za jezičnu primjerenost preuzimaju autori. Tekst sažetka piše se u Win word programu i može sadržavati maksimalno 250 riječi (bez naslova, imena autora i pripadajućih institucija). Potrebno koristiti razmak 1, slova tipa Times New Roman i veličinu slova 12 te ne podebljavati naslov, imena autora niti tekst sažetka. Naslov se piše velikim slovima. U novi red upisati prezime i inicijale imena svih autora. Podcrtati ime autora koji će prezentirati rad. U novi red upisati punu adresu institucije u kojoj je rad izrađen. Ukoliko su autori iz različitih ustanova, pripadnost ustanovi je potrebno označiti brojevima. U novi red navesti adresu e-pošte autora koji će biti izlagač. Tekst sažetka treba započeti pisati u novom redu. Sažeci trebaju biti strukturirani i sadržavati sljedeće dijelove: Introduction, Materials and methods, Results, Conclusions.

Prihvaćeni sažeci tiskat će se u zborniku sažetaka. Sažetke molimo poslati isključivo putem online obrasca na mrežnoj stranici Hrvatskog društva farmakologa <http://pharma.mef.hr/> do 10. srpnja 2016. Organizatori će do 20. srpnja 2016. obavijestiti autore o prihvatanju sažetaka.

Abstracts should be written in English, in the Win word program and should not exceed 250 words (without titles and the names of authors and their institutions). As abstracts will not go through language editing, the responsibility for their language accuracy lies with the authors. Line spacing should be single, font Times New Roman, font size 12, without bolded title, author names or text itself. The abstract title should be in capital letters. The line below the title should contain the surnames and first name initials of all authors, with the presenter's name underlined. The following line should state the full name of the institution at which the paper was created. If the authors are from different institutions, their affiliations should be marked by numbers. The next line should contain the presenter's e-mail address. The abstract itself should begin in the following line. Abstracts should be structured and should contain the following sections: Introduction, Materials and methods, Results, Conclusions. The abstracts must not be previously published.

The accepted abstracts will be published in the Book of Abstracts. Abstracts should be submitted by July 10, 2016 by the online form which can be found at the webpage <http://pharma.mef.hr/>. The authors will be notified regarding the acceptance of their abstracts by July 20, 2016.

Veličina postera treba biti do 120 cm visine i do 90 cm širine. Tekst treba biti napisan na engleskom jeziku i sadržavati sljedeća poglavља: Introduction, Materials and methods, Results, Conclusions, References. Od autora se očekuje prisutnost uz poster tijekom vremena predviđenog za prezentaciju i raspravu. Stručno Povjerenstvo dodijelit će nagrade za najbolji poster iz temeljnih i kliničkih znanosti, na svečanoj dodijeli nagrada prije zatvaranja kongresa.
